

REQUEST FOR QUALIFICATIONS FOR INDEPENDENT EVALUATORS RFQ #13230201

The Heart of Texas Workforce Development Board (the Board) is soliciting interested and qualified individuals to serve as independent evaluators to review and score various procurements such as RFPs/RFQs/RFAs the Board may conduct between May 1, 2023, through September 30, 2024.

Selection

The Board intends to contract with at least three outside evaluators as a result of this RFQ. The Board will establish a pre-qualified vendor's list from which to select evaluators as the need arises. Offerors must identify the types of procurements they are qualified to assess and evaluate. This will be an open procurement to evaluate procurements for the Board for the dates specified. Offerors placed on the pre-qualified vendor's list will remain on the list for one fiscal year. Vendors on the bidders list are provided with an option to renew annually for three additional years.

Immediate need: the Board is seeking evaluators available to review the current RFP #13230101 Workforce Solutions for the Heart of Texas Center System Operator/Manager, within the timelines listed below. Qualifications

The selection will be based on the following criteria. Individuals interested in serving as independent proposal evaluators must address the following criteria below in the Evaluator Oualifications:

- 1. Knowledge and / or experience with local workforce development boards. https://twc.texas.gov/partners/workforce-development-boards.
- 2. Thorough knowledge and understanding of the operations and management of Workforce regulations and programs https://twc.texas.gov/programs.
- 3. Work experience in the areas of education, workforce development and/or grant funded programs.
- 4. Demonstrated professional experience evaluating and scoring proposals for workforce and/or Child Care services and/or similar programs.
- 5. Demonstrated knowledge, understanding and/or experience evaluating budgets.

Compensation

Selected evaluators will be paid no less than \$400 per proposal thoroughly evaluated for procurements under \$250k and no less than \$700 per proposal for procurements over \$250k, depending on complexity. Evaluators will be paid a flat cost rate to review and score written proposals. This flat rate also requires attending calls as necessary. Offerors must complete the evaluation of all proposals received in entirety and attend requested meetings. Travel is not anticipated for these engagements, however, if necessary, any travel costs will be reimbursed based upon actual expenses, not to exceed maximum state rates.

Conflict of Interest

Selected evaluators must assure that they have no real or apparent conflict of interest in reviewing proposals with vendors. If an evaluator finds that there is conflict of interest, the evaluator must immediately recuse themselves from the evaluation.

Response

Interested individuals must complete and submit complete and submit the Evaluator Qualifications Form (Attachment A). Three professional references and a resume that supports the information in the qualifications should be included. Cover letters are optional.
